Feedback from Lisa Zorn



- Future goals for the project
 - Using the methodology of the "Circles of Social Life Approach" project by Paul James will be a helpful source for the Caring Cities Initiative. There are many other projects that used similar methodologies for their research. It is important to be aware of them and to take advantage of them. Finding a methodology for the CCI (Caring Cities Initiative) creates a grounded basis for the future work. Please have a look at this book: "An Introduction of Qualitative Research" by Uwe Flick 2014.
 - Focusing the project on just a few major key points/elements will secure that the aim of the project will be achieved without loosing sight of it.
 - The definition of dimensions and how they describe the elements for the CCI is from essential meaning.
- Different data sources of the cities need to be collected, listed and agreed by the group.
 - Organization of the Group
 - For communication in the group during the time until the next meeting it could be helpful if
 you send us a very short report every month or every two month to update everyone on the
 procedure of the project.
 - Creation of a communication pool: We agreed on skype meetings, E-Mail contact and dropbox as a file stock for the project. Please send a list with all skype names to the group.
 - What is happening with the papers which some of the cities have handed in for the last meeting in Buenos Aires?
 - Working task and written style for papers need to be defined before each hand in deadline?

Feedback from Soledad Cubas



- Methodology for the development of the Barometer
 - With regard to what was presented in our last meeting, it would be ideal if the presented document is sent to all the participants of the group, so that doubts and concerns regarding the documents can be discussed by the group once the meeting has taken place.
 - "Circles of Social Life Approach" Professor Paul James: In relation to the exposed previously, it will
 be necessary that each one of the group's participants receives the work made by Prof. Paul James,
 with the objective of knowing in detail the initiative, methodology used, complexities found related
 to its design and learnings.
- It's necessary to:
 - Define a number/set of dimensions and what we understand by them
 - Understand what are the different data sources that have the cities of the
 - initiative
- Future Action Points
 - - Set an agenda of virtual contacts and potential future dates of group meetings
 - Define the type of communication channel or platform: Skype conference and notifications though Facebook
 - Design an action plan and work schedule
 - It is suggested that the working material for the following group meeting should be sent within a considerable timeframe.
 - It is proposed that the next working meeting lasts longer (scheduled) and according to a defined agenda
 - Develop a presentation schedule for the reference panel (internal and external)



Feedback from Georg Smitchgen

• "I think the barometer's indicators are too many and therefore blur the concept of "caring". Therefore, I suggest to focus on the dimensions "Social Inclusion" and "Protection of the vulnerable". I think this focus fits the idea that in modern society tribal and family ties are dissolving and therefore these "homebases" aren't there anymore with regard to taking care of the weak members of society. Thus, the city's administration has to step in. By the way, in Germany this kind of social caring is in the sole responsibility of the communities and cities. So, the question of who is responsible for this kind of policy is clear. With regard to the dimension of "natural environment" for instance this is not so clear making it problematic to have the correct object for research if you are just observing the cities. Concentrating on "Social Inclusion" and "Protection of the vulnerable" provides an unique selling point for the barometer and would provide a clear concept of "caring".



Feedback from Darlington Mushongera

- Possible ways to improve future contact session meetings.
- Pre-contact assignments
- Instructions on what to prepare sent well in advance and submission process clear (i.e. sending to all members or to Zayd).
- Insist on members to read those submissions and give input during contact session.
- Give members a chance to present their papers and respond to questions from rest of group
- Plenary discussion on how all this can be incorporated into the main project.
- This means a two day workshop instead of one.

Conceptual understanding

- Impress upon it in your report and in the next meeting.
- Members to be encouraged to restate it and comment on it.
- Work as team on the presentation to be shown to the reference team.

Reference group feedback

- I suggest the following process
- We present to them our collectively generated ppt.
- We leave the room
- Have them discuss (the goods, the bads, etc)
- Bring us back in
- Issue an unified statement (comment on pros, cons and then their agreed statement)
- Have us respond/comment
- Conclude/and an agreement of way forward.
- This way both parties will go away with a clear understanding of what to expect in the next session
