ToR: procurement of consultancy services Internationalisation for local authorities' executive course

1. Introduction

Metropolis has been an independent association since 1985 and is a platform for the most prominent metropolises in the world to **connect**, **share experiences and respond deftly to emerging local and global challenges**. With over 140 local and regional government members from over 60 countries, our organisation fosters global cooperation, dialogue and sharing knowledge and solutions, grounded in the experience and empathy of its members.

Metropolis announces professional services for the development of an offline course of internationalisation especially for the development of the methodology and part of its content.

2. Background¹

As it currently stands, local policy management and the exercise of the corresponding powers by local government entails the need to build connections with international stakeholders and incorporate them in this field. In conjunction with this, international agendas are settings for decision making in which representation, visibility and influence must be put into practice, considering the repercussions and challenges that result from decisions taken in the local sphere. However, in a context of scarce resources and pressing social and economic challenges, outside action cannot be seen as a "luxury" by local governments, and must instead be seen as a robust and effective mechanism to provide citizens with better living conditions. In a dynamic in which major cities and metropolitan areas stand to gain from their participation in the international arena, what can these cities and areas provide global citizens in return?

Recent changes to the international action of local governments are the result of several concurrent phenomena. Not only are we observing an exponential growth of international activism, but an evolution of how local governments relate to the rest of the world. The latter include the increasing professionalisation of local government offices of international relations and a broadening of focus, no longer restricting local government as beneficiaries or donors of international cooperation, but also as stakeholders involved in the global agenda. Internationalisation has gradually gained crosscutting space within the institutional, political, and territorial objectives of local administrations, moving towards becoming strategic action and, eventually, public policy.

Taking this context into consideration and building on its 30+ years of experience at the service of local authorities, Metropolis will offer, in 2023, a first-of-its-kind, accredited executive training in

Internationalisation for Local authorities, to provide the participants the tools and knowledge to foster international action in their territory.

With the present Terms of Reference (ToR), the Metropolis Secretariat General opens a call for tenders to carry out the creation of a learning methodology and to create the content of a training course about internationalisation for local authorities.

1. 3. Objective

Metropolis will organise an on-site course on internationalisation for local authorities in Barcelona. The objective of this tender is to select the applicant(s) that will be tasked to designing the course contents and detailed methodology, under Metropolis supervision and based on the outlined methodology as detailed below.

The training course will have a **duration of 15 teaching hours (5 days course)** and will be structured around theoretical content through lectures by experts (not part of the tender) as well as practical content with field visits. The course aims to offer a basis for training, updating and deepening the concepts and skills of the participants in relation to the international actions of local authorities but also:

- To understand if international action can add value to their city/metropolitan area
- To learn how to build an internationalisation strategy
- To provide participants with tools that will enable them to propose strategies and practical solutions for the internationalisation of their local authority.

Once finalised, the consultancy services will provide the following elements:

- 1) Detailed step by step methodology for each Unit of the course (including types of dynamics and exercises)
- 2) Theoretical background for each Unit of the course (including types of dynamics and exercises, theoretical background should not exceed 1h30 of teaching time).
- 3) Examples of case studies that could be used for each Unit of the course² (including types of dynamics and exercises)
- 4) Suggestions of side visits that can be organised, with their contextualization.

² Case studies examples should reflect Metropolis membership or local government that are not part of Metropolis but having similar characteristics with its membership.



In order to ensure consistency in content and style of the material of the course, Metropolis will provide two publications related to internationalisation which will serve as the basis for the development of the content:

- The first publication "Monitoring internationalisation strategies in cities and metropolitan areas" is an attempt to systematise and bring together the practical learnings of five Metropolis' members, and to summarise them in a format that can help other city administrations begin to respond to these questions above.
- The second one "<u>The Internationalisation of metropolitan spaces</u>" (Issue Paper 09), aims to contribute towards knowledge management about international action in metropolitan spaces, inviting reflection on the contributions that metropolises can make to the planet, and presenting new ideas to the debate on international action taken by local governments.

4. Course's Methodology³

Metropolis wants to structure the course around four blocks:

Metropolis Learning Station

Students will be given access to the Course's page on the <u>Metropolis Learning Station</u>, on all-in-one space for off-line curated materials to follow the course at your own pace.

Small Group Engagement

With limited seats, the *Metropolis Executive Training: Course on Internationalisation for local authorities* will maximise the interactions between participants and lecturers. Additionally, this style allows for debate opportunities that will be organised around the different case studies that will be studied as part of the course's program.

Networking

Specific activities are included in the course program to ensure that participants get to know their peers and opportunities to spark dialogue and potential collaborations are created.

Study Visits

Across the week, onsite visits to international actors of the Barcelona metropolitan territory will create opportunities to exchange on their internationalisation strategies.

The course methodology should incorporate **participatory dynamics** to involve participants in the co-creation of the content.

5. Study Plan of the course

The content of the course should be developed around the following structure:

- **Unit 1**: City Diplomacy in a changing international context (Understanding the global context and opportunities)
- **Unit 2**: Strategies of Internationalisation
- **Unit 3 & 4 (divided in two parts)**: Designing the international action (Structuring, coordinating & contextualising in your territory)
- **Unit 5**: Monitoring and Communicating the international action

6. Conditions

Language: All the deliverables should be delivered in English. Once delivered, Metropolis reserves its right to translate to any other languages the content of the course, without prior consultation to the consultancy service.

Ownership: Metropolis will remain the sole owner of all intellectual property delivered through the consultancy services. Metropolis reserves its right to edit and adapt the course content to any other format it sees fit.

Editing and layout: The Metropolis Secretariat General will be in charge of editing and layout of any content. All related files must remain confidential.

Private or public institutions, universities, think tanks, consultancies, groups of experts, academics, or individuals with proven experience in the analysis of internationalisation strategies of cities and metropolitan spaces and who has also been involved in the creation of a course content
