## Cities Alliance runs workshops on migration and localising SDGs

Bern, 17-18 October

In the Swiss city of Bern, Metropolis took part in a series of workshops, organised by Cities Alliance and the Swiss Agency for Development and Cooperation (SDC), on migration and how cities can localise the SDGs.

The Cities Alliance invited its members, as well as its Swiss and international partners, to expert workshops covering these topics (17 October: “The role of cities in localising the SDGs” and 18 October: “Cities and migration”).

Metropolis was represented at the event by Eugeni Villalbí, Project Officer for the Metropolis Observatory. The sessions included a discussion and exchange of experiences and ideas to find new frameworks, new approaches and new tools applicable to the topics covered during the workshop. Proposals that, at the same time, should establish the basis of the strategic guidelines underlying the action plan for the Cities Alliance over the years to come.

## Festival MegaCities ShortDocs

Paris, 19 October

Metropolis has started a partnership with the film festival MegaCities ShortDocs (MC-SD). Founded in 2014, the Parisian association MC-SD brings together short documentary films that reflect the challenges faced by megacities –

urban areas with more than 10 million inhabitants. There are 38 megacities in the world today, and 24 of them are already members of Metropolis. The best short documentaries in the 2017 festival were shown on 19 October in Paris.

## 3rd EMA Conference

Warsaw, 20 October



Warsaw hosted the third edition of the European Metropolitan Authorities (EMA) conference, an initiative led by the Barcelona Metropolitan Area. Topics such as metropolitan solidarity and the role of metropolitan areas in EU cohesion policy post-2020 were discussed, and good practices for collaboration between metropolitan areas were shared.

The Metropolis Secretary General, Octavi de la Varga, moderated the session called

“Metropolitan Solidarity: spreading income and inducing development”, with the participation, from our membership, of the Barcelona Metropolitan Area and the Metropolis of Lyon, and also of Nice, the Silesian Metropolitan Area and Tirana.

## World Cities Day Forum

Guangzhou, 31 October

Metropolis supported the World Cities Day, jointly organized by the city of Guangzhou and UN-Habitat. The Mayor of Guangzhou, Mr. Wen Guohui, and the Metropolis Secretary General, Mr. Octavi de la Varga, participated in a dialogue with other mayors from cities in China, Italy and the United Kingdom on sustainable urbanization and on the governance of the cities. This dialogue highlighted the need for new governance models that take into account, among other things, the impact of metropolitan spaces not only in the metropolitan environment itself but in the set of territories of a given region. Likewise, the importance of responding quickly to the needs of an increasingly diverse and heterogeneous citizenship was highlighted.



In addition, Agnès Bickart, Senior Manager for Institutional Relations and the Metropolis Asia Portfolio, together with Sunil Dubey, Metropolis Senior Advisor, took part in the workshop: "International Urban Cooperation Asia: Smart Cities and Development in China".



## Participation at the International Conference of the European Forum of Urban Security

The International Conference of the European Forum of Urban Security (EFUS) on “Security, Democracy and Cities: a Joint Production of Urban Policies on Security” was held in Barcelona. During the conference, a workshop on “Prevention of Violence against Women” co-organized by Metropolis was held, and attended by Mrs. Maria Naredo, the Director General of Awareness and Prevention for Gender Violence in the Municipality of Madrid.

## Observatory on Subnational Government Finance and Investment

Paris, 16-17 November

The Observatory on Subnational Government Finance and Investment had its public launch and first formal meeting at the OECD headquarters in Paris on 17 November, 2017. Metropolis was represented at the event by the Secretary General, Mr. Octavi de la Varga, and by Mr. Eugeni Villalbí, Project Officer for Metropolis Observatory.

The project is run by UCLG, the OECD and the Agence Française de Développement (ADP), while Metropolis is involved as a member of the Steering Committee. The project is the result of work that began in 2016, with the same partners, through the publication of a report titled, “Subnational governments around the world: Structure and Finance”. The aim of the project is now

to go one step further and create a stable space to analyse the financing systems of more than 100 countries around the world. The goal is to build a transparent and accessible database, create tools to help train subnational governments in this field, and to promote an international dialogue that also favours multilevel governance in areas related to finance.

The next step will be to work during 2018 to maximise the number of countries analysed, and start collecting data. The first conclusions from the study will be presented at the end of this year, or at the beginning of 2019. Then the next step is to progressively consolidate a global network of experts and institutions that contribute to broadening knowledge in this area.

## Global Compact for Safe, orderly and regular migration

Puerto Vallarta, 4-6 December

In Puerto Vallarta, Mexico, was held the stocktaking meeting of the Inter-governmental Conference to adopt the Global Compact for Safe, Orderly and Regular Migration.

It was during this meeting that Ms. Valérie Plante, the new Mayor of Montréal, presented a position paper submitted by Metropolis to the Global Compact for Safe, Orderly and Regular Migration and

the Global Compact for Refugees, also included in the New York Declaration. The Metropolis position paper had previously been sent to Mrs. Louise Arbor, Special Representative of the Secretary-General for International Migration, to Mr. Filippo Grandi, 11th United Nations High Commissioner for Refugees (UNHCR), as well as to the Secretary General of the United Nations.

# The New Urban Agenda and its implementation: towards a better urban governance

The guide leaves a legacy for our membership, and will hopefully contribute to the development of future Metropolis projects which deal with the planning and management of the metropolitan territories surrounding major airports, such as the new project “METROAirports: socioeconomic impact and uses of new-generation airports”, led by the Barcelona Metropolitan Area.

### Pilot Projects: 1st meeting on intersectionality in metropolitan LGBTI policies

Montevideo and Buenos Aires, 12-15 December

Montevideo and Buenos Aires hosted the first meeting for the project "Intersectionality in Metropolitan LGBTI Policies". This project involves the metropolises of Montevideo, Medellín, Mexico, Berlin, Barcelona and Buenos Aires, and aims to draw together common knowledge so that an intersectional perspective can be incorporated in policies aimed at LGBTI persons, where the acronym stands for Lesbian, Gay, Bisexual, Trans and Intersex. The intersectional approach aims to acknowledge that all

people, including those who identify as LGBTI, are affected by multiple inequalities and that this intersection creates a new kind of discrimination, which differs from the sum of these inequalities. The main talking point covered in this first meeting was the situation that LGBTI migrants and refugees face.

### Cities Alliance General Assembly

Jinja, 13-15 December

Hélène Jourdan, Project Officer for Learning, Strategic Partnerships & Focal Point for Africa, travelled to Jinja, Uganda, to take part to the Cities Alliance General Assembly meetings.

Members of Cities Alliance participated in the field visits organized to see different projects, including a visit to KibugaMbaata, an informal settlement that lacks services of physical and social infrastructure. A

development plan was prepared in 2016 by Caritas, in collaboration with the Makerere University, Actogether, Slum Dwellers International and local partners to improve the inhabitants' basic services of this neighborhood.

During the successful three-day meeting, members of the Assembly approved the Strategic Plan for the forthcoming four-year term, in which gender is mainstreamed.

### Metropolis initiatives: Youth, Sport, and Social Cohesion

Barcelona, 14-15 December

Barcelona hosted the "Youth, Sport and Social Cohesion" conference, which was organised by the Institut Barcelona Esports of the Barcelona City Council and the association Metropolis. Over the course of two days there were debates, meetings and sharing of experiences in which youth sport activities could be rethought, revised and analysed in terms of their social contributions.

A bicycle tour was also organised so as to provide different experiences with athletics and social cohesion in public spaces of Barcelona.

This conference represented the final event of the Metropolis Initiative "Youth, Sport and Social Cohesion", a three-year project launched in 2015 with the goal of promoting a social and athletics-based network for athletic entities and organisations that use sport as a mechanism for social cohesion.

## Metropolis Observatory: Metropolitan Indicators System

### **5th edition of the Global Observatory on Local Democracy and Decentralization (GOLD) report: metropolitan chapter**

Metropolis is involved in coordinating the metropolitan chapter of the GOLD-V report that will be published in 2019, focused on the localization of the SDGs. In this sense, in November of 2017, Metropolis and UCLG

signed a collaboration agreement, which is materialized with the direct involvement of the Metropolis Observatory team and a financial contribution of 13,000 €, 56% of the cost of the metropolitan chapter.
