Quito, 19-24 January

The Summit welcomed over 1000 participants, and was the first Global Forum on Migration and Development Summit (GFMD Summit) to host civil society, private sector, local authority, youth and academia representatives as integrated participants in the Summit. Organized as an integral part of the program, the 6th Mayoral Forum on Human Mobility, Migration and Development brought the perspective and expertise of local authorities into GFMD discussions, and called for concrete steps towards the multilevel governance promoted by the Global Compact on Migration.

Gender Keys 03: "Metropolitan governance and gender equality: a challenging relationship?"

06 February

In the framework of Metropolis' commitment to gender equality, the Gender Keys collection offers tools and case studies implemented by members, to stop gender inequalities and improve the right to the city for all inhabitants.

In this matter, Metropolis launched the Gender Keys 03 "Metropolitan governance and gender equality" which focuses on the challenges of metropolitan governance facing gender issues. In just two pages and with a comprehensive language, we

analyze the urban consequences of an obsolete governance model that excludes the plurality of existing views and voices. The struggle of women and vulnerable groups to penetrate governance structures is strictly related to a gender-blind public space. When we talk about governance, we refer to the exercise of leadership and the power to take decisions. This vision, prevalent in different contexts around the world, is a result of the limited access of women and vulnerable groups in governance structures.

Metropolis actively participated at both political and technical levels in the 10th World Urban Forum (WUF10) held in Abu Dhabi.

Our association marked its political presence with the representation of our members in the World Assembly of Local and Regional Governments. This assembly focused on how urbanization shapes and is shaped by culture and heritage. The discussions started looking at global partnerships and initiatives for sustainable urbanization and then revolved around how urbanization affects and is affected by culture and innovation. Speakers debated on the role that urban and territorial policies can play in preserving cultural heritage and how local governments can maximize the relationship between tradition, culture and sustainable urbanization.



30 March

Clearing House, a European Union’s Horizon 2020 Research and Innovation funded project, kicked-off last September. This project, aims to use trees as a means to improve urban living in both Europe and China, and brings together 26 partners from across the spectrum, including prestigious universities, national research institutes, international and national non-profits, SMEs, and botanical gardens.

Concretely, Clearing House will analyse and develop the potential of Nature-Based Solutions (NBS) in general, and UF-NBS in particular – across China and Europe – in order to enhance the resilience of cities

facing major ecological, socio-economic, and human wellbeing challenges. The project will be organized around 5 pillars: Reviewing existing knowledge on NBS, carrying out Sino-European case studies, facilitating learning, developing tools, and increasing NBS awareness.
